適應症: 血栓性栓塞症及其預防、抗凝血。

藥理分類: Anticoagulant.

用法用量: Administration: Subcutaneous, IV infusion (intermittent or continuous),

****NOT for IM**, (due to pain, irritation, and hematoma formation).

Indications and dosage regimens:

Note: Therapeutic anticoagulant effect with full-dose heparin:

adults based on 68 kg.

Patients \geq 60 yrs may require a lower dosage.

Anticoagulant therapy; Treatment and Prophylaxis:

-Full-dose, intermittent IV injection

Adults: 10,000 units bolus then 5000-10,000 U Q 4-6 H OR 100 U/kg every 4 hrs. Children: 50 units/kg bolus then 50-100 units/kg every 4 hrs.

—Full-dose, continuous IV infusion

Adults: initial 5000-10,000 units bolus (OR 100 units/kg) then 1000-1250 units/hr OR 20,000-40,000 units/day (in 1 L of NS).

Children: 50 units/kg bolus then 10-25 units/kg/hr OR 20,000 units/m² over 24 hours.

—Full-dose, SC injection

Adults: 5000 units IV bolus followed by 10,000-20,000 units SC, then 8000-10,000 units Q8h OR 15,000-20,000 units Q12h.

Disseminated intravascular coagulation (DIC):

IV infusion or IV injection every 4 hours. Discontinue after 4-8 hours if there is no improvement.

- -Adults: 50-100 units/kg
- Children: 25-50 units/kg

不良反應: 出血,注射部位局部刺激、輕度疼痛、血腫等。

注意事項: 1.Heparin sodium 個體感受性差異大,投與前應作感受性試驗,投與後應測血液凝血時間,再決定維持量。

- 2.手術病人、腎功能不良和肝功能不良之患者應小心使用本劑。
- 3.若開始使用口服抗凝血劑,則應減少本劑之劑量繼續使用 4-5 天,直至口服藥物獲得完全抑制凝血素原活性。

懷 孕 期: 1.沒有相當的資料顯示這種藥物是否會影響男性或女性的多產,或形成畸型胎的可能性或對子宮的不良反應。

- 2. Heparin does not cross the placenta (ESC [Regitz-Zagrosek 2018]).
- 3. Heparin may be used for anticoagulation in pregnancy (ACOG 196 2018).
- 4. Due to a better safety profile and ease of administration, the use of low molecular weight heparin (LMWH) is generally preferred over heparin (unfractionated heparin.
- 授 乳 期: 1. Heparin is **not present in** breast milk (Bates 2018).
 - 2. Heparin is considered acceptable for use in breastfeeding women (Bates 2018)
 - 3. However, some products contain **benzyl alcohol** as a preservative; their use in breastfeeding women is contraindicated by some manufacturers due to the association of gasping syndrome in premature infants.
